

HMK® S35 Stone Sealer -matte finish-



Protective sealer that reduces the penetration of water, dirt and oily/greasy substances. For all rough and absorbent natural and artificial stone surfaces.

The colour and structure of the surface will be enriched.

Facilitates regular cleaning and overall maintenance.

HMK® S35 is a ready to use colour enriching surface protector with a matte finish that reduces the penetration of water, dirt and grease into honed, brushed, sandblasted, flamed and riven soft and hard natural stone surfaces, agglomerates, concrete and terrazzo. The colour and structure of the surface will be enriched whilst leaving a matte finish. Facilitates regular cleaning and overall maintenance, especially on rough and textured surfaces. For internal use only.

Note: S35 will not be effective on polished and very fine-honed stones, glazed ceramic/porcelain and non-absorbing surfaces. For internal use only.

Important: Do not walk on the treated surface until treatment is completed and thoroughly dried (6-12 hours). Once applied protect surface from rain and humidity for 12 hours. Do not apply to rubber, plastics, varnished surfaces and solvent intolerant surfaces. Remove all foodstuffs from the treated areas before work is commenced.

Instructions: If under floor heating exists, switch it off and allow the surface to cool. Clean surface thoroughly and let it dry (max residual moisture of 2-4%). Apply S35 generously and evenly with a soft brush, HMK® Z170-171 Application Brushes or a roller with short fibres. If colour has not been enhanced sufficiently, repeat treatment after 12 hours.

The residual material is not harmful to health.

To clean surface thoroughly before treatment use HMK® R55 Intensive Cleaner -acid free.

For regular cleaning and continued protection use HMK® P24 Liquid Stone Soap, a no-rinse natural product.

Coverage: About 5-20m²/litre.

Warning: Chemical product. Contains naphtha. Flammable. Keep away from heat, sparks and flame. Harmful or fatal if swallowed or inhaled. Ensure the area to be treated is adequately ventilated. Avoid eye/skin contact. If exposed wash/flush with water and seek medical attention immediately. Keep out of the reach of children. See Material Safety Data Sheet for more detailed information.

Packaging: 12 x 1 litre bottles/box; 4 x 5 litre cans/box; 2 x 10 litre cans/box.

Storage: Store in a cool place and keep lid tightly closed.

Testing: Always test the product in an inconspicuous area to evaluate suitability, coverage and performance. Do not use the product in temperatures below 12 and above 25°C.
